



Guide for Healthcare Professionals Prescribing iAluRil® from Part IX NHS Drug Tariff and dispensing from a Home Delivery Service (DAC)

Process for obtaining EPS FP10 prescription for iAluRil® and having it dispensed by Select Home Delivery Service

The below guidance is a means of navigating through the process required in order to have prescriptions fulfilled and dispensed by Select Home Delivery. It remains the patient's choice as to where their prescriptions are filled and dispensed. The following steps must be undertaken when using Select Home Delivery:

- 1) **Register a patient with Select Home Delivery.**
 - a) This can be done by the patient themselves or by their hospital HCP via telephone on **0800 783 7027** (Obtain verbal consent from the patient to use EPS via Select as their nominated dispenser) or
 - b) Email your interest at Select.uk@wellspect.com with your contact telephone number so that a member of the Customer Care team can call you and obtain the required information of your patient to be able to then register them on the Select service.
- 2) **Inform the GP surgery**
 - a) Patient has been registered and nominated Select Home Delivery Service (Wellspect Ltd) as one of their dispensing providers through Electronic Prescription Service (EPS).
- 3) **Inform the GP surgery**
 - a) The patient should quote FQ608. This is Select Home Delivery (Wellspect Ltd) NHS Organisational Dispensing code and is a unique identifier that will make it easy for the GP to locate them on the EPS system.
- 4) The GP will issue the FP10 EPS prescription for iAluRil to the NHS spine (<https://digital.nhs.uk/services/spine>), from where Select Home Delivery Service will pick up the prescription and dispense the product to the patient's home.
- 5) **Hospital prescribers:** Hard copy FP10 prescriptions can be sent to:

Points to remember:

1. Should the patient not be registered, then Select Home Delivery Service (Wellspect Ltd) cannot dispense the item.
2. This dispensing route has been set up in order to limit footfall to community pharmacies during these restricted times.
3. Select Home Delivery Service (Wellspect Ltd) can only dispense against an EPS and or FP10 hard copy prescription
4. Select Home Delivery Service (Wellspect Ltd) are only licensed to dispense medical devices and cannot dispense products that require a pharmaceutical license / PL#
5. Patients can have more than one nominated home delivery service; however, we have chosen to partner with Select Home Delivery Service (Wellspect Ltd) and placed iAluRil stock available with them for this purpose.
